Dear Mr. Thorpe & Stop the #Karen Recall of Mayor Lamar Thorpe 2022,

The Enforcement Division of the Fair Political Practices Commission enforces the provisions of the Political Reform Act (the "Act").<sup>1</sup> The Enforcement Division received an anonymous complaint alleging that you may have violated the Act's campaign disclosure provisions. The complainant alleges:

*Campaign Statements Not Filed  
Semiannual Statements (84200)*

*The committee received a contribution in the amount of \$2500 in December of 2021 and failed to file a form 460*

Additionally, a piece of evidence submitted with the complaint is enclosed for your reference.

At this time, we have not made any determination about the allegations made in the complaint. We are requesting information, including documentation, about the allegations described above. **Please submit your response in writing within 14 days** from the date of this letter to Ginny Lambing at [glambing@fppc.ca.gov](mailto:glambing@fppc.ca.gov), or the address provided above. Upon receipt of your response, we will review the information to determine whether or not to investigate the allegations.
