**INFORMATION - FELONY**

Count 1) VC10851(a)

**COUNT 1 – DRIVING OR TAKING A VEHICLE WITHOUT CONSENT**

The undersigned states, on information and belief, that Artis Chavez Crenshaw Jr, Defendant, did commit a Felony, a violation of VC10851(a), Driving Or Taking A Vehicle Without Consent, committed as follows:

On or about July 2, 2023, in the County of Contra Costa, State of California, the crime of Driving Or Taking A Vehicle Without Consent in violation of VC10851(a), a Felony, was committed in that ARTIS CHAVEZ CRENSHAW JR did drive and/or take a vehicle, a 2016 Nissan Frontier, without the consent of the owner, Willie Hawkins, and with the intent to deprive the owner of title and/or possession of the vehicle.

**COUNT 2 – RECEIVING STOLEN PROPERTY, MOTOR VEHICLE**

The undersigned states, on information and belief, that Artis Chavez Crenshaw Jr, Defendant, did commit a Felony, a violation of PC496D(a), Receiving Stolen Property, Motor Vehicle, committed as follows:

On or about July 2, 2023, in the County of Contra Costa, State of California, the crime of Receiving Stolen Property, Motor Vehicle in violation of PC496D(a), a Felony, was committed in that ARTIS CHAVEZ CRENSHAW JR did unlawfully buy and/or receive a 2016 Nissan Frontier that was stolen and had been obtained in a manner constituting theft and extortion, knowing the property to be stolen and obtained, and did conceal, sell, withhold, and aid in concealing, selling and withholding said property.

**COUNT 3 – FLEEING A PURSUING PEACE OFFICER'S MOTOR VEHICLE WHILE DRIVING RECKLESSLY**

The undersigned states, on information and belief, that Artis Chavez Crenshaw Jr, Defendant, did commit a Felony, a violation of VC2800.2, Fleeing A Pursuing Peace Officer's Motor Vehicle While Driving Recklessly, committed as follows:

On or about July 2, 2023, in the County of Contra Costa, State of California, the crime of Fleeing A Pursuing Peace Officer's Motor Vehicle While Driving Recklessly in violation of VC2800.2, a Felony, was committed in that ARTIS CHAVEZ CRENSHAW JR while driving a motor vehicle in a willful and/or wanton disregard for the safety of persons, and with the intent to evade, willfully fled and/or attempted to elude a pursuing peace officer's motor vehicle.



**COUNT 4 – POSSESSION OF FIREARM BY A FELON - PRIOR(S)**

The undersigned states, on information and belief, that Artis Chavez Crenshaw Jr, Defendant, did commit a Felony, a violation of PC29800(a)(1), Possession Of Firearm By A Felon - Prior(s), committed as follows:

On or about July 2, 2023, in the County of Contra Costa, State of California, the crime of Possession Of Firearm By A Felon - Prior(s) in violation of PC29800(a)(1), a Felony, was committed in that ARTIS CHAVEZ CRENSHAW JR did unlawfully own, possess, purchase, receive, and have custody and control of a firearm, to wit, an AR Style pistol, the said defendant, ARTIS CHAVEZ CRENSHAW JR having theretofore been duly and legally convicted of a felony or felonies, to wit:

**SPECIAL ALLEGATION-TWO PRIOR OFFENSES-ELIGIBILITY FOR PROBATION**


