**COUNT 1 – PANDERING BY PROCURING**

The undersigned states, on information and belief, that Keith Ernest Haywood, Defendant, did commit a Felony, a violation of PC266l(a)(1), Pandering By Procuring, committed as follows:

On or about January 30, 2026, in the County of Contra Costa, State of California, the crime of Pandering By Procuring in violation of PC266l(a)(1), a Felony, was committed in that KEITH ERNEST HAYWOOD did unlawfully procure Jane Doe, another person, for the purpose of prostitution.

**COUNT 3 – CARRYING A LOADED FIREARM / PRIOR CONVICTION**

The undersigned states, on information and belief, that Keith Ernest Haywood, Defendant, did commit a Felony, a violation of PC25850(a)/(c)(1), Carrying A Loaded Firearm / Prior Conviction, committed as follows:

On or about January 30, 2026, in the County of Contra Costa, State of California, the crime of Carrying A Loaded Firearm / Prior Conviction in violation of PC25850(a)/(c)(1), a Felony, was committed in that KEITH ERNEST HAYWOOD did unlawfully carry a loaded firearm on the person or in a vehicle while in a public place or on a public street in an incorporated city and in a public place or on a public street in a prohibited area of unincorporated territory.
