COUNT 1 – CONTACT WITH MINOR FOR SEXUAL OFFENSE

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC288.3(a), Contact with Minor for Sexual Offense, committed as follows:

On or about June 14, 2022, in the County of Contra Costa, State of California, the crime of Contact with Minor for Sexual Offense in violation of PC288.3(a), a Felony, was committed in that CHRISTOPHER GEORGE MILLER did unlawfully contact and communicate with a minor JANE DOE #1, knowing that JANE DOE #1 was a minor, with the intent to commit an offense specified in Penal Code Section 207, 209, 261, 264.1, 273a, 286, 287, 288, 288.2, 289, 311.1, 311.2, 311.4, and 311.11 involving JANE DOE #1.

COUNT 2 – MEETING MINOR FOR LEWD PURPOSES

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC288.4(b), Meeting Minor For Lewd Purposes, committed as follows:

On or between March 10, 2023 and March 16, 2023, in the County of Contra Costa, State of California, the crime of Meeting Minor For Lewd Purposes in violation of PC288.4(b), a Felony, was committed in that CHRISTOPHER GEORGE MILLER did unlawfully and motivated by an unnatural and abnormal sexual interest in children, arrange a meeting with JANE DOE #2, a minor and a person defendant, CHRISTOPHER GEORGE MILLER believed to be a minor, for the purpose of exposing the genitals and pubic and rectal area of JANE DOE #2 and defendant, CHRISTOPHER GEORGE MILLER, and to engage in lewd and lascivious behavior, and did go to the arranged meeting place at and about the arranged time.

COUNT 3 – CONTACT WITH MINOR FOR SEXUAL OFFENSE

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC288.3(a), Contact with Minor for Sexual Offense, committed as follows:

On or between March 10, 2023 and March 16, 2023, in the County of Contra Costa, State of California, the crime of Contact with Minor for Sexual Offense in violation of PC288.3(a), a Felony, was committed in that

CHRISTOPHER GEORGE MILLER did unlawfully contact and communicate with a minor JANE DOE #2, knowing that JANE DOE #2 was a minor, with the intent to commit an offense specified in Penal Code Section 207, 209, 261, 264.1, 273a, 286, 287, 288, 288.2, 289, 311.1, 311.2, 311.4, and 311.11 involving JANE DOE #2.

COUNT 4 – DISTRIBUTING OR SHOWING PORNOGRAPHY TO A MINOR

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC288.2(a)(2), Distributing Or Showing Pornography To A Minor, committed as follows:

On or about March 14, 2023, in the County of Contra Costa, State of California, the crime of Distributing Or Showing Pornography To A Minor in violation of PC288.2(a)(2), a Felony, was committed in that CHRISTOPHER GEORGE MILLER knew, should have known, or believed that another person was a minor, and knowingly distributed, exhibited and sent harmful matter to that person with the intent of arousing, appealing to, or gratifying the lust or passions or sexual desires of the defendant, CHRISTOPHER GEORGE MILLER or of the minor, and with the intent or for the purposes of engaging in oral copulation with the other person. and that either person touch an intimate body part of the other.

COUNT 5 – DISTRIBUTING OR SHOWING PORNOGRAPHY TO A MINOR

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC288.2(a)(2), Distributing Or Showing Pornography To A Minor, committed as follows:

On or about March 15, 2023, in the County of Contra Costa, State of California, the crime of Distributing Or Showing Pornography To A Minor in violation of PC288.2(a)(2), a Felony, was committed in that CHRISTOPHER GEORGE MILLER knew, should have known, or believed that another person was a minor, and knowingly distributed, exhibited and sent harmful matter to that person with the intent of arousing, appealing to, or gratifying the lust or passions or sexual desires of the defendant, CHRISTOPHER GEORGE MILLER or of the minor, and with the intent or for the purposes of engaging in oral copulation with the other person. and that either person touch an intimate body part of the other.

COUNT 6 – ATTEMPTED LEWD ACT UPON A CHILD

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC 664/PC288(a), Attempted Lewd Act Upon A Child, committed as follows:

On or about March 16, 2023, in the County of Contra Costa, State of California, the crime of Attempted Lewd Act Upon A Child in violation of PC 664/PC288(a), a Felony, was committed in that CHRISTOPHER GEORGE MILLER did willfully, unlawfully, and lewdly attempted to commit a lewd and lascivious act upon and with the body and certain parts and members thereof of JANE DOE #2, a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant, CHRISTOPHER GEORGE MILLER and the said child.

COUNT 7 – ATTEMPTED SALE/OFFER TO SELL/TRANSPORTATION OF MARIJUANA

The undersigned states, on information and belief, that Christopher George Miller, Defendant, did commit a Felony, a violation of PC 664/HS11360(a), Attempted Sale/Offer To Sell/Transportation Of Marijuana, committed as follows:

On or about March 16, 2023, in the County of Contra Costa, State of California, the crime of Attempted Sale/Offer To Sell/Transportation Of Marijuana in violation of PC 664/HS11360(a), a Felony, was committed in that CHRISTOPHER GEORGE MILLER did unlawfully attempted to transport, import into the State of California, sell, furnish, administer, and give away, and offer to transport, import into the State of California, sell, furnish, administer, and give away, and attempt to import into the State of California and transport marijuana.

Complainant requests that the Defendant[s] be dealt with according to the law.
